The appointment of the above candidates, as "Junior Engineer" (Civil) (as prescribed in the above said Govt. Order) shall further subject to the following conditions;

1. Each appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his/her Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his/her appointment as Junior Engineer in the Jal Shakti (PHE) Department shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.

2. That if the candidate(s) has taken loan for self-employment from DIC/Employment Department to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before the joining the Government Services. He/she shall be required to repay the entire lean liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
3. The salary of the appointees shall not be drawn and disbursed to him/her unless satisfactory report in respect of genuineness of his/her qualification/Relevant Category Certificate/ Date of birth and other pre-requisite certificate(s) is received from the concerned issuing authority.
4. The inter-se-seniority of the appointees shall be determined in accordance with the merit secured by him/her in the selection list prepared by the J&K Services Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
5. The appointment of the candidates shall be governed by the "New Pension Scheme as per SRO- 400 of 2009 dated 24.12.2009.
6. The candidate(s) appointed under RBA and ALC/IB category shall be posted in such areas at least for 7 years.
7. The appointee(s) shall be on probation for a period of two (02) years
8. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before a competent Court of Law.
