Consequent upon joining of Mr. Mohd. Kabir Brother of Late Shabir Ahmed S/o Wali Mohd. R/o Village Buffleaz Tehsil Surankote, District Poonch on 04-03-2024 in this office, who is appointed vide Govt. order No. quoted under reference in terms of Clause-2A of Jammu and Kashmir Rehabilitation Assistance Scheme, 2022, as Class-IV/MTS in District cadre Poonch in the pay level of SL-1 (Rs. 14800-47100) and further posted/adjusted in the office of Executive Engineer, Jal Shakti (PHE) Division Poonch.

The appointment of the above candidate, as Class-IV/MTS (as prescribed in the above said Govt. Order) shall further be subject to the following conditions;

1. That he shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/Date of Birth/Category Certificates if any, from the concerned issuing authorities are found to be fake/forged, the claim of the appointee for appointment as Class-IV/MTS shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
2. That if the candidate has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before the joining the Government Services. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
 - a) The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of Qualification/Date of birth/Category Certificate, if any, is received from the concerned Authorities.
 - b) The appointee shall on probation for period of two years.
 - c) The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated: 24.12.2009
 - d) The appointment of the above appointee shall be subject to outcome of writ petition(s) if any, pending before Competent Court of Law.
