The appointment of the above candidate, as "Junior Engineer" (Civil) (as prescribed in the above said Govt. Order) shall further subject to the following conditions;

1. Appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification from the concerned issuing authorities, any of the above certificates are found to be fake/forged, his/her appointment as Junior Engineer in the Jal Shakti (PHE) Department shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
2. Appointee shall furnish a certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any self-employment scheme has been availed by the candidate. In the alternative, if the candidate(s) has taken such a loan, to be ascertained by the DDO concerned from the District Industries Centre (DIC) and District Employment and Counseling Centre, he/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO Concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
3. The salary of the appointee shall not be drawn and disbursed to him/her unless satisfactory report in respect of genuineness of his/her qualification/Degree Certificate/Relevant Category Certificate/ Date of birth and other pre-requisite certificate(s) is received from the concerned issuing authority.

The inter-se-seniority of the appointees shall be determined in accordance with the merit secured by him/her in the selection list prepared by the J&K Services Selection Board and in terms of J&K Service Selection Board in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
5. The appointment of the candidate shall be governed by the "New Pension Scheme" in terms of SRO- 400 of 2009 dated 24.12.2009.
6. The candidate(s) appointed under RBA and ALC/IB category shall be posted in such areas at least for 7 years.
7. The appointee(s) shall be on probation for a period of two (02) years
8. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before a competent Court of Law.
